Description

The 2-ft. and 4-ft. Vehicle Hitch Mount Extensions (DH-13 and DH-13/4FT) install between the Vehicle Hitch Mount Sleeve (DH-12) and the attendant vehicle. The extensions allow the attendant's vehicle to be parked further away from the entry point.

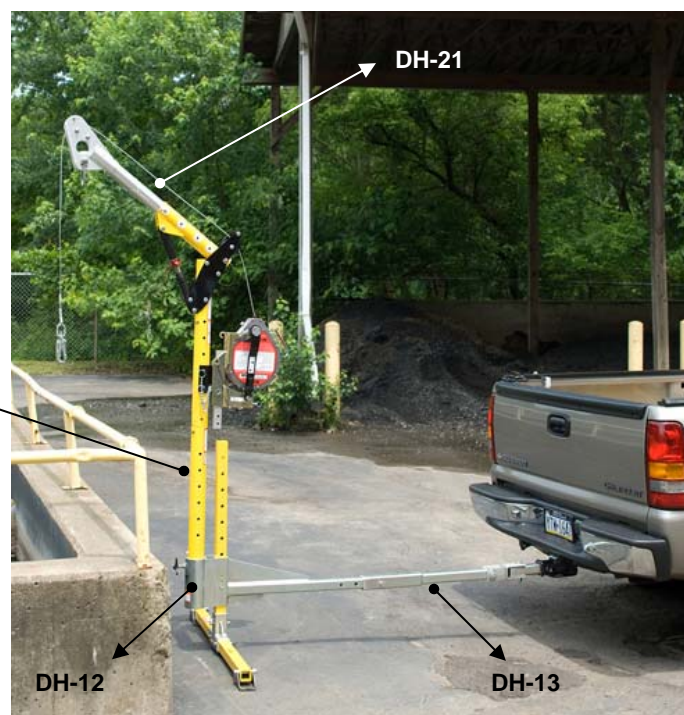
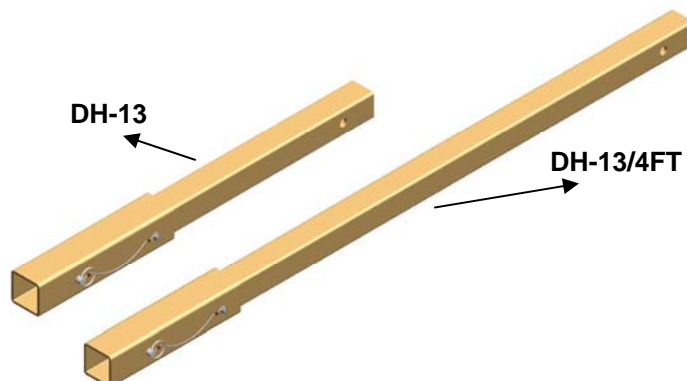
