

Honeywell North® Primair® 700 (PA700) Series Connected Powered Air Purifying Respirator (CPAPR)

The Honeywell North PA700 PAPR Honeywell upgraded the PA700 blower with a low-energy Bluetooth transmitter. Power on the Bluetooth-enabled PAPR, and the system will automatically begin to transmit real-time, operational data. A mobile application turns your smartphone into a gateway. Whenever it's in range of the connected blower, the phone will push the device data to the Honeywell cloud. Honeywell's Safety Suite web application aggregates and processes the data - enabling valuable insights for those ready to optimize their PAPR fleet management processes.

The following Frequently Asked Questions pertain to the Connected technology implemented on the PA700 Connected PAPR.

Q1: When can I get a Connected PA700 PAPR?

A1: PA710C blowers will begin shipping May 2019 and the PA710C connected blower with Bluetooth technology will be offered as standard in all PA700 kits at no additional charge.

Q2: How can a Connected PA700 PAPR help me in my work environment?

A2: Access to connectivity can improve your PAPR fleet management. Over time, insights from the data aggregates can help increase worker productivity and save money on consumables. Real-time insight can assist in digitized asset management, access to valuable use and consumable data, in-depth operational insight, and proactive consumable replenishment.

Q3: What mobile platforms does this work on?

A3: The gateway application is available for download from the Google Play store, for Android only. An iOS version is under development and is targeted for release in late 2019. The mobile application is free to download and access to Safety Suite for PAPR users will be free, for a limited time.

Q4: How do I get connected?

A4: Purchase a Connected PA710C (standard in PA701x kits) and install the the mobile gateway application on your smartphone. Follow mobile app instructions to register your device(s).

Q5: Do I need a gateway for every connected PAPR device?

A5: No. A single gateway can service up to 15 devices that are within range (approx. 25ft)

Q6: If mobile phones are not permitted in the environment, then what?

A6: At this time, we do not have any other gateway solutions; a mobile phone is required as a gateway.
